Since 2002 the Legacy of Love Foundation, originally named the Scholarship Endowment Fund of the Philadelphia Alumnae Chapter of Delta Sigma Theta Sorority Inc., has remained committed to our mission to fund academic scholarships and to encourage community leadership in education, economic empowerment, health, and the arts.

With the generous help of our donors we continue to work towards our goal of 1 million dollars in the Scholarship Endowment Fund. Thanks to an extremely generous gift of \$95,000 from the Philadelphia Alumnae Chapter of Delta Sigma Theta Sorority, Inc., we are closer than ever to that goal. Our partners are committed to supporting Philadelphia area high school students in their higher education careers. To date we have granted over \$321,000 in scholarships and over \$78,000 in grants to local area non-profits.



Together with our donors great and small, we are making a difference in the lives of our youth and enabling non-profits in our community to continue their good work. We continue to increase annually the amount provided in scholarships to deserving high school graduates. In these challenging times, we are still in the business of making a way for others and recognizing those creating their own legacies.

In June 2022 we awarded \$22,000 in academic scholarships. We also awarded \$6,000 in grants to community nonprofits in furtherance of our mission to encourage community leadership in education, economic empowerment, health, and the arts.

Thank you once again for being a part of this success story. The challenges we face in our communities are great—food insecurity, housing discrimination, health disparities—but not insurmountable. We can and do make a difference when we come together to lift our young people and provide them with opportunities to meet their educational and personal goals.

WHO WE ARE OUR HISTORY



In 1992, Liller B. Green, an active member of Delta Sigma Theta's Philadelphia Alumnae Chapter, challenged the membership to plan for the future of our community's most valuable resource: our children. Her business sense, foresight and love for Delta Sigma Theta Sorority, Inc. led her to make a personal gift of \$25,000 to establish a scholarship endowment foundation with the stipulation that the

Philadelphia Alumnae Chapter match the gift within five years.

Chapter members answered Liller Green's challenge in just one year! The original \$50,000 raised was used to establish the Scholarship Endowment Foundation as a nonprofit, 501(c)(3) organization. To increase the fund, a five-year campaign was initiated in 1997 with the goal of raising \$250,000 towards endowment funding. In 2004, the name of the Scholarship Endowment Foundation was changed to the "Legacy of Love Foundation, Inc.," reflecting the expansion of the nonprofit organization's mission beyond scholarship awards to include supporting community-based programs in the priority areas of:

- Physical and Mental Health
- Economic Empowerment
- Educational Development
- The Arts

Since 1993, over \$300,000 in scholarships has been awarded to collegebound students throughout the Philadelphia area. Additionally, over 50 community organizations have been recipients of grants to support their work in the priority areas of the foundation.



The Legacy of Love Foundation's vision is to transform lives through the power of philanthropy, health, and the arts.



IMPACT: PAST SCHOLAR

Christina Williams was a 2018 scholarship recipient and attended Central High School at the time of her award. As a first-generation college student, she recently graduated from Clark Atlanta University (CAU) and will soon be entering law school.

How did the scholarship impact your time at CAU?

Something that really had an impact was the financial help. I was a first-generation college student and I was also an independent student since high school; so that means I don't have parents that support me financially throughout my education. My entire education expense I had to figure out a way to cover by myself. I got a full scholarship; they covered room, board & tuition, but there are a lot of hidden fees... books, food when the café is closed, just wanting to have fun and enjoy life as a college student. Also, the mentorship that stayed with me throughout college.

What extracurricular activities did you participate?

My first couple of years I did a lot in student government. I also really got involved in politics in Atlanta. My freshman year in 2018 was the first time Stacey Abrams ran for governor so I was able to volunteer for her campaign. I also did a lot of nonpartisan work at my school. I founded an



organization called CAU Votes. We helped students register to vote and make sure they know who was on the ballot. We had a lot of candidates come on campus and answer questions from students.

Why do you want to be a lawyer?

Just having been a voting rights organizer in GA it was very rewarding on one end, but it was also very draining, angering and saddening especially over the past few years. I knew that I could get a lot done... but it just felt like it wasn't enough for me. I felt I was capable of doing a lot more. I've received so many privileges to get a college degree, especially where I come from. I'm a West Philly native. So I felt like since I had the opportunity, I should gain every tool that I can. I call myself "a translator". I want to go out and get the understanding and learn it myself so I'm able to translate those complex legal issues in our communities around things that impact us.
